#### 24.47 Shropshire Councillor's Report

Cllr Claire Wild raised the Town and Parish Council Survey that had been circulated by Shropshire Council looking at the future options of working with Parish Councils in delivering in local communities in initiatives such as cutting around road signs and cleaning gullies. She noted that it would not result in 100% reimbursement for costs. At this stage it is a consultation, and thinking how it could be used to address little but annoying things within the community. The Environmental Maintenance Grant has worked well but this initiative would give direct control and would save a lot of time chasing things up.

A meeting had been held with Haworths. Work will be starting on access roads in October. There has been a route improvement from the JPC Quarry, it won't come through Cressage village.

#### 24.51 Other Parish Matters

## i. Under 11 Play Area:

Funding for accessible play equipment is ongoing. Cllr Rob Davies said that he would look at Blakemore Foundation as a possibility.

It was resolved to not proceed with surfacing work. It was agreed that the surface flooring in the play area is in reasonable condition and does not require replacement or repair at this time. It does need cleaning, and it was agreed to ask the contractor to clean up the matting and the wood edges.

It was agreed to proceed with hedge cutting all the way around the play area. The Chairman, Cllr Victoria Todd, said she would inform the neighbours about the hedge cutting. It was also agreed to proceed with drainage works.

As a matter of safety, fences should be secured all around the edges, there should be one entrance and one exit to it.

It was agreed to get three quotes for the tree works and for the drainage. The Parish Clerk would liaise with Cllr Matt Murray about a spec for the work.

The success of the work party was noted, about 15 people turned up for it.

# ii. Footpaths

A works party has cleared the main road to the bridge. Shropshire Council officers came to look at the bridge but access to it was impeded so the visit was postponed.

## iii. 30mph speeding sign

There were no further updates. The work still has not been completed.

# iv. Speeding

Cllr Rob Davies reported that the Blakemore Foundation had provided planters for the village sign and that this was meant to slow cars down. There was discussion about the possibility of extending this to place a village gateway sign on the verges. This would need permission from Highways

#### v. Defibrillator

Med UK have inspected the defibrillator at Cressage Village Hall and have replaced the battery as it had a fault on it. It is now fully operational and is registered with the Circuit. It was agreed that the numbers listed with Numbers Plus should be checked to ensure they are up-to-date.

### vi. Combined Village Event

It had been questioned if Councillors would be willing to support a combine village event possibly to include tug-of-war. It was resolved to assist in helping the event.

#### vii. Christmas Tree

Councillors would be willing to support putting up a Christmas Tree if the Village Hall wanted to go ahead. Power supply and cost of it would be the main issue.

#### viii. Benches

The Blakemore Foundation has granted two benches for the use of the community. The Asset Register will be updated accordingly.
